A Public Hearing will be held on the above data and time to consider the following requests:

1. Carl Sarbacker requests approval of a Conditional Use Permit for a Landscape, Lawn and Garden Business located at 7646 Conifer Court, in the Village of Windsor.
2. Rick Trinko requests approval of a Certified Survey Map to adjust lot lines between property located at 3561 and 3567 Windsor Road, a Rezone of property from ER – Estate Residential Zoning District to A-2(4) – Agriculture Zoning District and a Conditional Use Permit for a Limited Family Business, in the Village of Windsor.
3. Tri County Paving, Inc. requests approval of a Rezone from A1-EX – Exclusive Agriculture Zoning District to NMO – Nonmetallic Mining Operation for property located in the Northwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$, the Northeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$, the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$, and the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 23 AND the Northwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$, and the Northeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 26, all in the Village of Windsor. The property is further described as being generally located South of Vinburn Road, West of Highway C and North of Windsor Road.
4. An ordinance amendment to Chapter 52-29 of the Windsor Code of Ordinances regarding standards for keeping domestic fowl in single family residential yards.
